



The Summary of Benefits and Coverage (SBC) document will help you choose a health [plan](#). The SBC shows you how you and the [plan](#) would share the cost for covered health care services. **NOTE:** Information about the cost of this [plan](#) (called the [premium](#)) will be provided separately. Important Questions	Answers	Why This Matters:
What is the overall deductible ?	Network providers: \$2,500/individual, \$2,500/individual under family, or \$5,000/family Out-of-network provider: \$6,000/individual, \$6,000/individual under family, or \$10,000/family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. The deductible is Embedded . If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . Deductible year runs 08/01 – 07/31
Are there services covered before you meet your deductible ?	Yes. Preventive care services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive care without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	Network providers: \$5,000/individual, \$5,000/individual under family, or \$10,000/family Out-of-network providers: \$13,000/individual, \$13,000/individual under family, or \$27,000/family	The out-of-pocket limit is the most you could pay in a year for covered services. The out-of-pocket limit is Embedded . If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums , balance billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider ?	Yes. See http://www.cmsmbenefits.com or call 844-801-1912 for a list of network	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance

Do you need a referral to see a specialist ?	No.	You can see the specialist you choose without a referral .

Does this plan provide Minimum Essential Coverage? Yes

Minimum Essential Coverage generally includes [plans](#), health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage.
